Annual Notice: Women's Health and Cancer Rights Act (WHCRA)

In accordance with federal law, the Health Plan provides benefits for mastectomy-related services including reconstruction and surgery to achieve symmetry between the breasts, prostheses, and complications resulting from a mastectomy (including lymphedema). The Plan is required to provide you with the following notice each year, which applies to breast cancer patients who elect to have reconstructive surgery in connection with a mastectomy.

Under federal law, group health plans, insurers, HMOs and EPOs that provide medical and surgical benefits in connection with a mastectomy must provide benefits for reconstruction surgery, in a manner determined in consultation with the attending physician and the patient, for:

- > all stages of reconstruction of the breast on which the mastectomy was performed;
- > surgery and reconstruction of the other breast to produce a symmetrical appearance; and
- > prostheses and treatment of physical complications at all stages of the mastectomy, including lymphedemas.

These benefits will be provided subject to the same deductibles, coinsurance, and copayments applicable to other medical and surgical benefits provided under the Plan.
